This grassroots investment is the only means to fight poverty in our remote village. We are seeking funding to expand our operations, upgrade infrastructure, and ensure long-term sustainability, thereby uplifting the economic and social fabric of our community.

With additional resources, we plan to construct 80 to 100 new ponds, upgrade our hatchery with durable materials, purchase modern equipment, and implement comprehensive training programs on sustainable practices. By enhancing our infrastructure and production capacity, we aim to double our fish production within 12 months, significantly improve the economic well-being of our community, and ensure a brighter and more prosperous future for all members.
